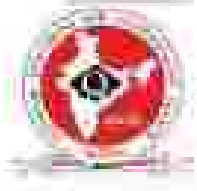

ABOUT THE INSTITUTION

TARANATH SHIKSHANA SAMSTHE :-

Founder Pandit Taranath, a multi-faceted personality- great visionary and ardent social reformer and a true humanitarian, founded Hamdard Primary School in the year 1920. Since then the school is catering to the needs of all including poorest of the poor . With the steady and marked growth the school has been elevated to the status of Junior college.

Pandit Taranath a visionary, a creator, an achiever, an ardent social reformer, a great humanitarian. Pandit Taranath revolted against the repressive measures of the Nizam and quit the teacher's post in protest and with the support of some like minded friends founded Hamdard Primary School in 1920. This primary School blossomed into a High School and is now Composite Junior College. To give shape to this vision in the field of education, a group of philanthropists of this area established the Raichur Education Society.

Raichur Education Society was later Named as Taranath Shikshana Samsthe as a mark of respect to the founder. Sri. Sheewarjal Somani was the First President and Sri.G.K.Rajpurthi was the Secretary. Sri. Soma Ramani Gowda was the President during 1963-87. Later on 1971 Late. Sri.M.Nagappa took over as the Secretary. During this period, B.R.B. College of Commerce, S.S.R.G. Women's College & S.C.A.B. Law College were established (1974). The present President Sri. Parasimal Sukhani took over in 1987 and since then several new job oriented courses, like B.B.M., B.C.A., P.G. Diploma in Fashion Design Technology and new subjects like Computer Science, Microbiology, & Bio-Technology have been introduced and there has been a special focus on quality education. The Management, comprising eminent persons drawn from different walks of life is known for its commitment, dedication and transparency. Selfless and self-effacing, the members, present and past, have put their heart and soul to ensure that quality education is imparted to the people of this educationally backward area, the poor and needy in particular.

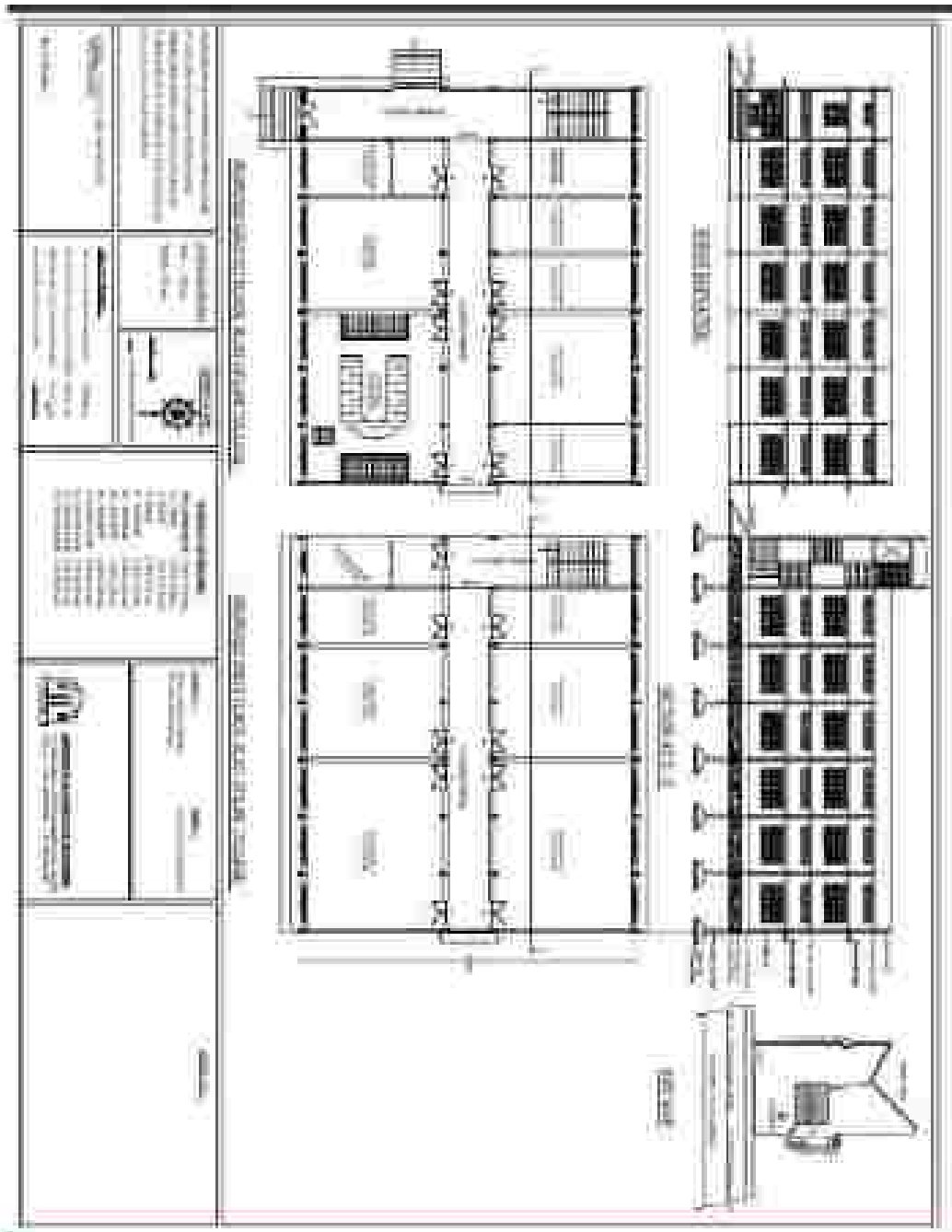

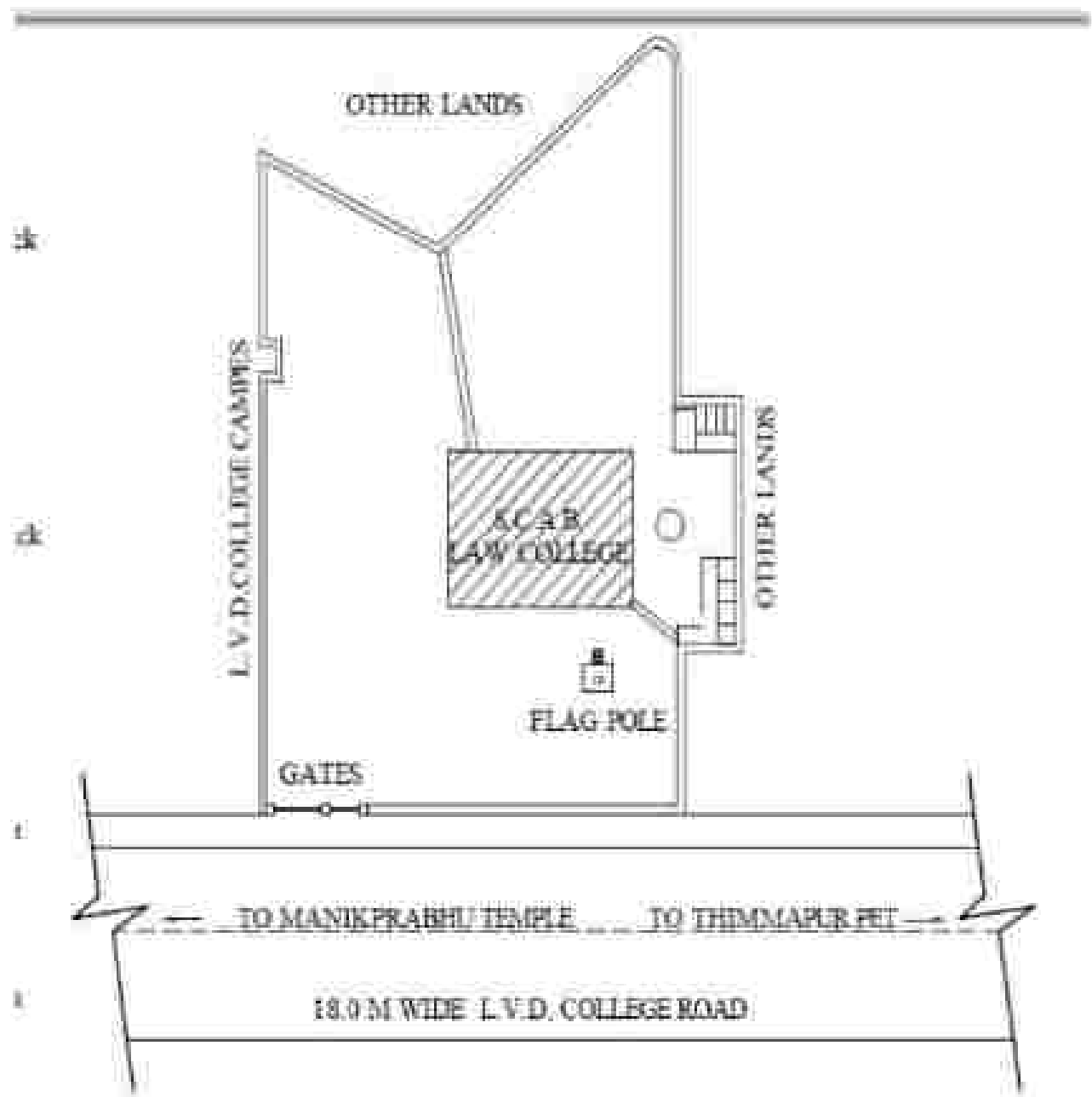

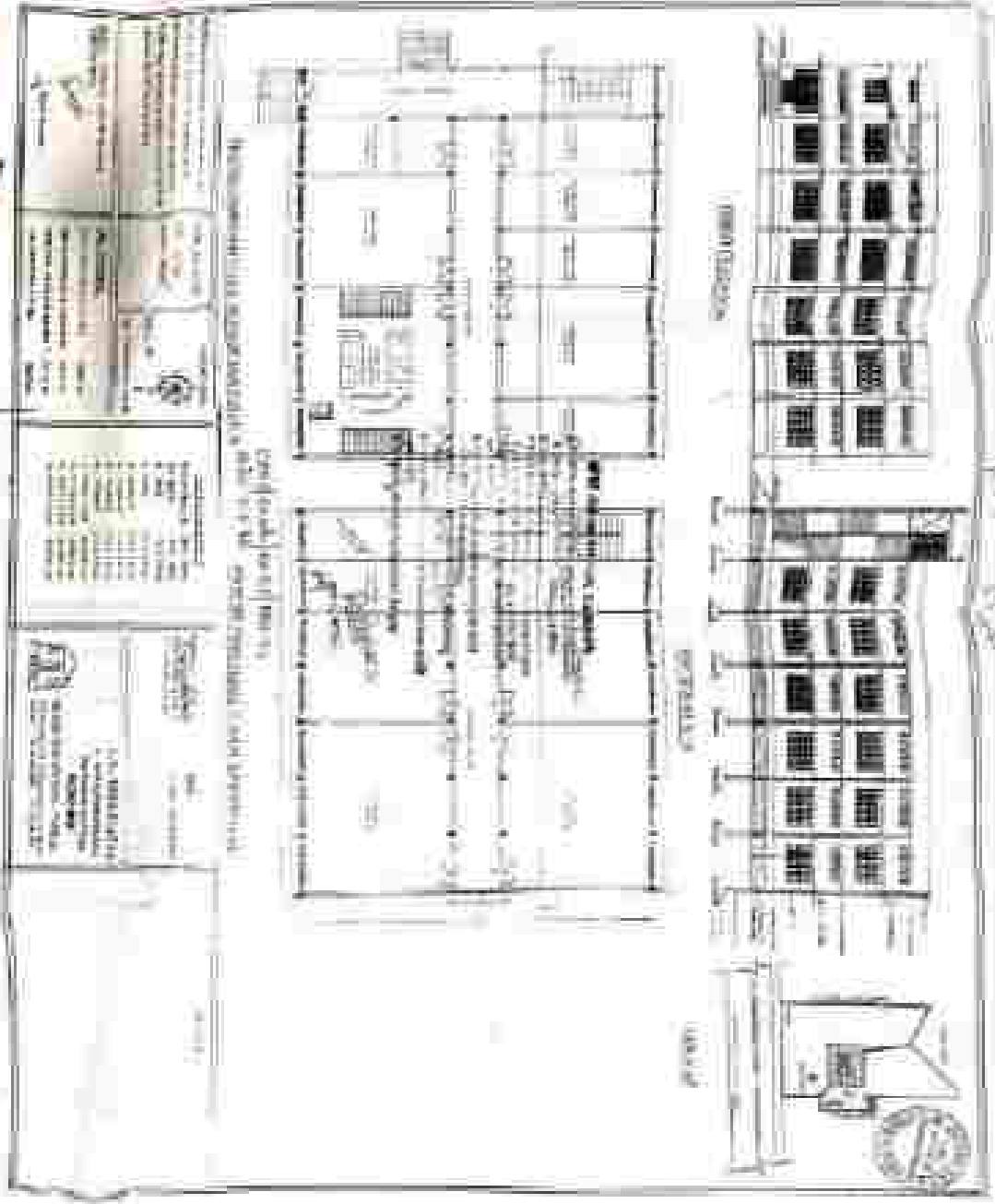
BUILDING PLAN AND MAP

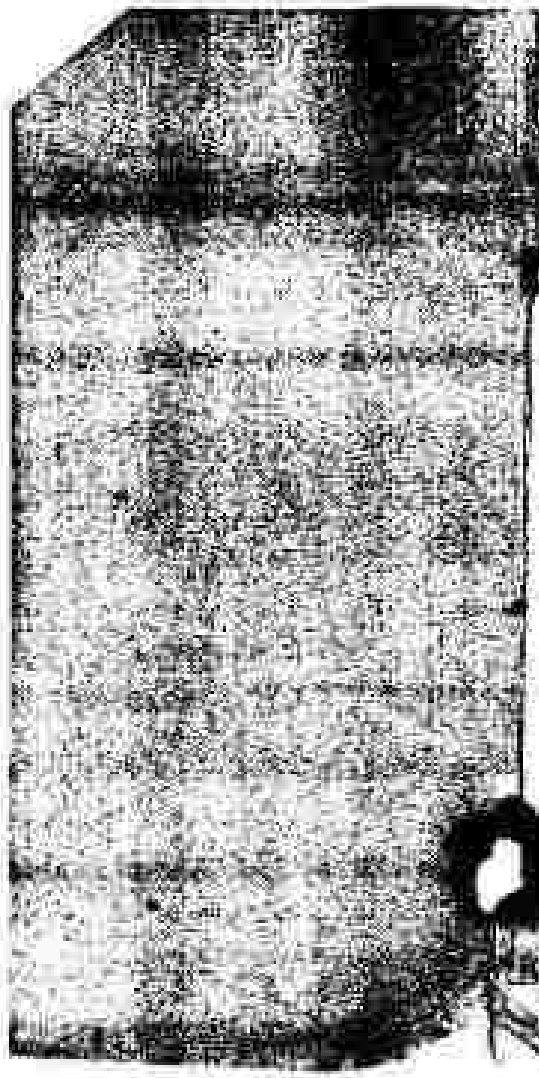

1. Name:-

The name of the Society shall be THE TARANATH SIKSHANA SAMITHI, RAICHUR. (The General Body of the Raichur Education Society, at its meeting held on 19/1/62, resolved unanimously to change the name of the Raichur Education Society to the TARNATH SIKSHANA SAMITHI, RAICHUR.)

2. Object:-

The objects of the Samithi shall be:-
a) To run the Handed High School, Raichur and the L.V.D. College, Raichur established by the Samithi.

- 2) The objects of Society shall be for the benefit of all members of same, and of all ages.
- RULE 5. DEFINITIONS:**
- 1) These rules and regulations shall apply to any being registered to or transferred to the subject named.
- a) "SOCIETY" :- Means the "Lawyer Students Society, Madurai"
 - b) "MEMBER" :- Means the member admitted to the Society.
 - c) "GOVERNING COUNCIL" :- Means a committee elected by the General Body of the Society, to manage the affairs of the Society.
 - d) "MANAGING COMMITTEE" :- Means the Committee constituted by the Governing Council.
 - e) "PRESIDENT" :- Means the President of the Society chosen by the Governing Council among its members.
 - f) "VICE PRESIDENT" :- Means the Vice President of the Society chosen by the Governing Council among its members.
 - g) "GENERAL SECRETARY" :- Means the Secretary of the Society elected by the Governing Council among its members.
 - h) "JOINT SECRETARY" :- Means the Joint Secretary of the Society elected by the Governing Council among its members.
 - i) "TREASURER" :- Means the Treasurer of the Society elected by the Governing Council among its members.
 - j) "PERSON" :- Means and includes an individual and female singular as well.

- RULE 6. MEMBERSHIP:**
- Eligibility :- Any person :-**
- a) Who is over 18 years of age and below 30 years (age limit)
 - b) Who is normal above all faculties or mad persons as within the limits of Madurai.
 - c) Who is not already a member of any other society or association of persons, that he is eligible to become member of the society, shall have the right to be admitted if who has taken the steps that the society or some committee for that purpose within any of the societies.
- Classes of Membership :-**
- There shall be four classes of membership:
- 1) Life
 - 2) Life Member
 - 3) Ordinary member
 - 4) Associate member
- 1) "Life" :- A person who pays Rs. 20,000/- and be admitted as a Life member of the Society.
 - 2) "Life Member" :- A person who pays Rs. 10,000/- and be admitted as a Life Member of the Society.
 - 3) "Ordinary Member" :- A person who pays Rs. 100/- and be admitted as Ordinary member of the Society.
 - 4) "Associate Member" :- A person who is nominated by the society.

- 1) That an opportunity of being heard at the General Body meeting shall be given to the member for a period of 1000/- is proposed to give.
 - 2) A member who is elected, but not be eligible to become a member of the Society for the next three years.
- RULE 7. GOVERNING COUNCIL:**
- 1) The affairs of the Society shall be managed or administered by the Governing Council consisting of 25 members, duly elected by the General Body.
 - 2) The General Body of the Society shall elect 21 members to the Governing Council once in 3 (three) years at General Body meeting at once.
 - a) One member from amongst the former members.
 - b) Ten members from amongst the life members.
 - c) Ten members from amongst the ordinary members.
 - 3) The Governing Council shall consist of 25 members. Ten female or Associate members from the Law Students Association / Regula / Pathi or any one from the members of the Society.
- Explanation :-**
- 1) The total number of members up to 25 should be elected as a whole, comprising 10/10 female/10/10 male from the Law Students Association / Regula / Pathi or any one from the members of the Society.
 - 2) All the members of the society shall be bound by the Rules and Regulations of the Society (which) existing in force by Associate Members.
 - 3) The member of Governing Council shall serve without remuneration. The details hereby refer / referring to the General Body / M.M.

- 4) If he fails to attend three consecutive meetings of the Governing Council without obtaining the reason of absence.
 - 5) Any member accused in any case shall be liable up to the Governing Council from the date of meeting.
 - 6) An office bearer of the Governing Council shall vacate his office on:

- RULE 8.** The Governing Council of Society shall be liable upon order to the functioning and discharge of all the institutions run by the Society.
- RULE 9.** The Governing Council shall be the body that accounts and funds matters of the Society and shall be entitled to deal with the same in the best advantage of the Society.
- 1) To purchase, lease or take on or otherwise, any or other immovable, movable or immovable property and rights in or interest therein or thereby, may take for the purpose of carrying on its business as aforesaid.

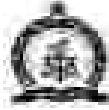


