



REPORT

Next Prof. Bhat discussed the major issues faced by Raichur and North-Karnataka, such as cyber bullying, domestic violence and child marriages. Cyber bullying is becoming rampant on social media platforms there should be legal awareness especially among women regarding the use of social media, and sharing personal photograph in social media platforms. Domestic Violence is an important social and legal aspect between the age group of 25-45 years. The main sociological factors are fear of divorce, impact on child psychology and awareness on behavioural change. The Protection Officers play a crucial role bringing awareness to the sociological and the legal facet of domestic violence. Prof. Sairam Bhat insisted upon the efforts to revive Legal Aid clinics.

Mr. Vikas Gahlot discussed the Consumer Protection Act. He emphasised that it is a key legislation relating to day to day life of every common man and the growth of apps like Swiggy and Zomato and others. He highlighted that Consumer Awareness should be at the forefront in today's technological and legal advancement. Citing an example of online food portals, he asserted the necessity to bring in consumer awareness especially in young generation, who have access to smart phones, regarding food safety standards, kitchen safety standards, plastic packaging and food grade audits in cloud kitchens. There is a prominence of legal awareness in the field of consumer rights in housing sector.

SESSION 3 - Question Answer Session




After the Technical

following key points -

 Regarding the strengthening of the Legal Aid Clinics in the

colleges and inculcating the attitude of social engineering in the students.

- The major concerns on Internet trolling and cyber bullying and how to be sensitive about the usage of social media platforms
- With plastic waste being so unbridled and a pandemic menace, the discussion was held on how to invoke Sec. 133 and powers of the District magistrate to solve the public nuisance.
- Discussion and deliberations on the child marriage, education to girls and people in general, the role of Child Protection Officers in disseminating the importance of education among girls.



SUMMARY OF THE PROCEEDINGS

The One-Day Workshop on Legal Literacy and Legal Awareness was organised under the aegis of the Department of Justice, Ministry of Law and Justice, Government of India in association with Seth Chunilal Amarchand Bohra Law College, Raichur and Centre for Environmental Law, Education, Research and Advocacy (CEERA), National Law School of India University (NLSIU), Bengaluru on 26th March 2022.

SESSION 1 - INAUGURATION



The Inaugural Speech was delivered by **Prof.** (**Dr.**) **Sairam Bhat**, Professor of Law & Coordinator, CEERA-NLSIU. In his Inaugural speech, Prof Bhat emphasised the need and importance of legal literacy and legal awareness campaigns in Raichur which is identified as one of the aspirational district in Karnataka for the Legal Literacy and legal Awareness Program (LLLAP). He highlighted the important social and legal issues such as child marriage, cyber bullying and women safety, social media

responsibility in digital age. Prof. Bhat further underscored the importance of legal awareness and legal literacy dissemination in such districts to involve law students and lawyers in this campaign of nation building and inculcating social responsibility. He discussed the initiatives of CEERA under the Project and the launch of CEERA Pro Bono Assistance helpline number.



The Key note address was delivered by **Sri Mahadevappa G.K.**, In-charge Principal District & Sessions Judge, Raichur. Reiterating Importance of legal education, Sri Mahadevappa stated that it is necessary to train the young minds during the college days and to make best use of legal literacy

program during the college days. He highlighted that it is very pertinent to train the students for social cause, practical importance and applied methods of legal principles, court practice and legal implementations.

In his speech, Sri Mahadevappa shared valuable insights on pending cases in courts and underscored the need for speedy disposal of cases. It is well known fact that the number of judges has to be proportional to the population. Hence, there is a pertinent need to increase the ratio of Judges in India. Citing the example of the Court in Raichur, He stated that the First Division Magistrate Court has around 5000 pending cases which includes cases under the POSCO Act, SC/ST atrocities cases, land acquisitions, Arbitration, Motor Vehicles along with civil criminal appeals and session trials. Even though the Special Courts are legally required to take cognizance of case within 30 days, take evidence on a day to day basis, and dispose of the case within a year, that is not the reality. He stated that the reasons for delay in court matters are many. One such being the supporting system from Police Department in evidences. With the online and virtual hearing of evidences gaining prominence the matters can be disposed in a speedy manner. He emphasised that in cases of POCSO and JJ Act, the virtual hearing and recording of evidence is a sensitive matter therefore In camera hearing shall be continued. Legal awareness should be disseminated

regarding the misuse of online virtual hearing, recording through mobile phones which is punishable offence.

He also underscored the significance of NCC, NSS in legal literacy and it can be an important aspect in the student training program. The legal aid campaign needs to be strengthened in order to enable the speedy and efficient disposal of cases.



The next address was delivered by Chief Guest Shri Maski Nagaraj, General Secretary, Taranath Shikshana Samsthe, Raichur. He was assertive in his statement that legal literacy campaign should also include training on criminal investigations to present it in the court of law. As an example he said that in the matters of NDPS the investigation is so


vital and crucial to the case in the courts and to prove the nexus between the offence and the accused. Legal awareness is very necessary to bring in practical knowledge and experiences. He also the emphasized the social responsibility of lawyers and educating the common people about the practices of child marriage and the need for the compulsory education

SESSION 2 - Technical Session



The Technical Session was taken by Prof. (Dr.) Sairam Bhat, Professor of Law & Coordinator, CEERA-NLSIU & Mr. Vikas Gahlot, Teaching Associate, CEERA-NLSIU. Prof. Bhat addressed the importance of Raichur as an aspirational district. He also emphasised the need for

mass grass root level out-reach through DOJ legal awareness program through the Class room and practical lawyering experimental Lab. He asserted the use of social Identity of a lawyer for societal responsibility.
