Parasmal Sukhani took over in 1987 and since then several new job oriented courses, like B.B.M., B.C.A., P.G. 1) Admissions made by the college are provisional.

Regulations governing the THREE year LL.B. Degree course in Law ELIGIBILITY CRITERIA FOR ADMISSION

- 1. An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for three year degree course in law leading to the conferment of LL.B. degree on successful completion of the regular programme conducted under these Regulations.
- 2. Minimum percentage of marks in qualifying examination shall not be below 45 % (44.5 % and above shall be treated as 45 %) of total marks in case of general category, 40 % of total marks in case of SC and ST applicants.
- 3. Maximum age for seeking admission is limited to thirty years in case of General category and thirty five years in case of SC, ST and other backward communities as on 1st June.

ADMISSION PROCEDURE

Admission to the course shall be made strictly on the basis of merit. While making admission to the course reservation policy of the Government of Karnataka governing admission to higher educational institutions issued from time to time shall be applied.

INTAKE

- 1. The intake for studies in Law under the Jurisdiction of Karnataka State Law University shall be 120.
- 2. As Sanctioned by the University Maximum of 120 students divided into two section of 60 students each are adimitted.

TUITION AND OTHER FEES

Candidate seeking admission to the LL.B. degree course and those admitted to such course shall pay the tuition and other fees as prescribed by the University from time to time. The Fee structure is subject to revision from time to time. Please contact the office for information.

CURRICULAM

- 1. Candidates admitted to the LL.B. course shall have to attend 06 Semester courses spread over 3 years.
- 2. In each Semester, the students shall have to study the courses prescribed by the University
- 3. The course descriptions shall be as set out from time to time by the Karnataka State Law University

MEDIUM OF INSTRUCTION

The medium of instruction in the LL.B. degree course shall be English. However, the examinees shall have the option to answer the question papers in the examination either in English or in Kannada.

ATTENDANCE

No students shall be permitted to appear for the end of semester examination in a given course unless he/she has, to the satisfaction of the course teacher, fulfilled the course requirements and has put in not less than 70% attendance in the course concerned.

A student shall be eligible for the award of the LL.B. (Bachelor of Laws) Degree after he/she has successfully completed all the prescribed courses in all the semesters and his or her character and conduct are found to be satisfactory during the course.

AWARD OF CLASSES

The award of classes shall be as under:

- 1. 70 % and more First Class with Distinction
- 2. 60 % and above but less than 70 % First Class
- 3. 50 % and above but less than 60 % Second Class
- 4. 40 % and above but less than 50 % Pass Class
