Government appointed five new additional judges to the newly appointed Karnataka High Court at an event organised at the Raj Bhavan.

The newly appointed judges are: Justice Narayan Venkatesh Gowda, Justice Sarveswar Sarvag Gowda, Justice M. Srinivas, Justice Chandrahasan, and Justice Sridhar Gowda.

Justice Gowda, born on February 15, 1967, was admitted as an advocate in 1991 after completing B.Sc. from St. Joseph's College of Arts and Sciences, and LL.B from IIM, Lake College, Bengaluru. During his 29-year long practice he represented the Indian Railways and its allied organisations before various courts.



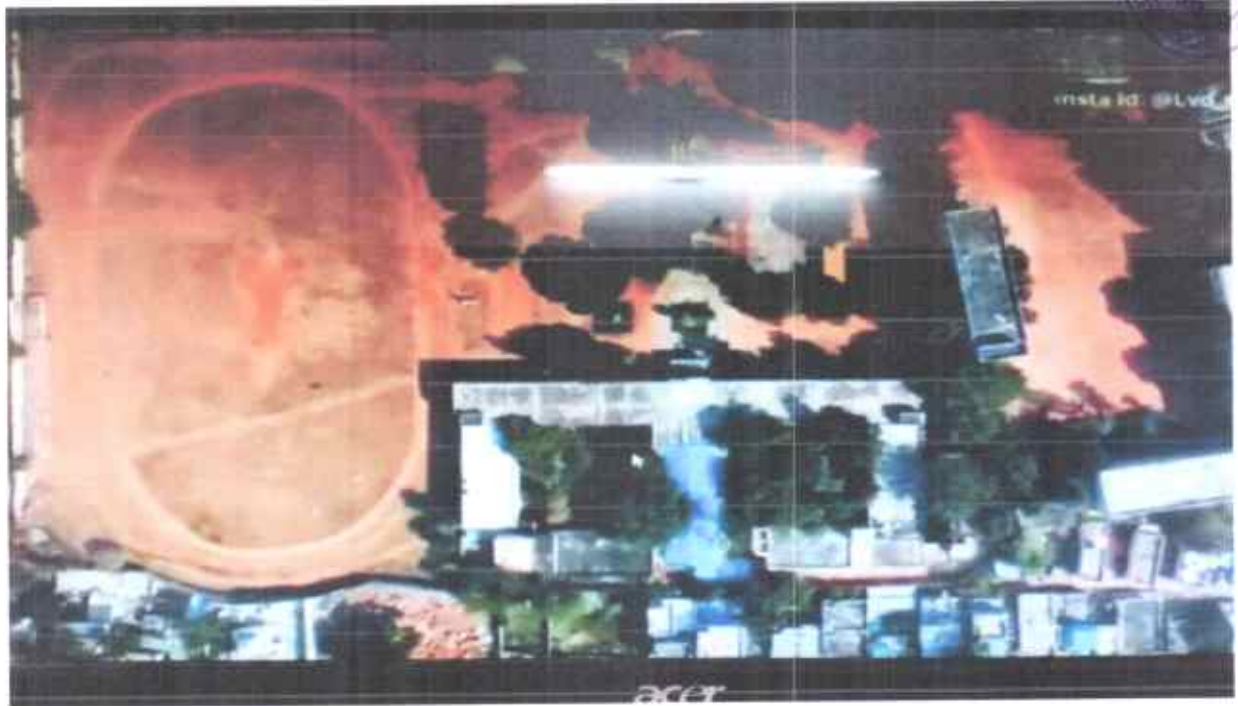
